Electoral Commission Recruits 74 New Staff

o address man-power shortage, the Electoral Commission recently recruited seventy-four (74) new members of staff, to strengthen operations at the headquarters and in the districts.

The new staff members, who include data entry operators, data editors, statisticians and other officers, to be deployed in the departments of Election Management, Voter Registration, Data Processing, and the Legal Department, were recruited through UNISIS, an independent firm.

The Electoral Commission held a two-day induction course for the seventy-four (74) newly recruited staff on 14th and 15th August 2003, at Fairway Hotel, Kampala.

Opening the induction course, EC Chairman Eng. Dr. Badru Kiggundu, formally welcomed the new officers and congratulated them upon passing through a rigorous recruitment process.

Dr. Kiggundu also urged the officers to embrace team-work and exhibit professionalism and integrity at all times. He reminded the new officers to be thorough and produce high quality work. "You have to justify your presence and stay at the Commission through your good performance. It is your challenge individually and collectively to work towards excellent performance", he said, and asked them to be flexible, and be prepared to be shifted from department-to-department, as need arises.

EC Hosts Kenya Constitutional Review Commission

n June 2003, members of Kenya's Constitutional Re view Commission (KCRC), were in Uganda, and visited a number of Institutions to share experiences, and learn from the The head of the delegation, Dr. Swazuri, pointed out a number of election-related issues raised by the people of Kenya, which include loop-holes in requirements and integration of special interest groups into the democratisation and electoral process.

Dr. Swazuri also highlighted other challenges like bribery, violence,

democratisation process in Uganda.

The delegation from the KCRC paid a courtesy call on the Electoral Commission, on 3rd July 2003, to acquaint themselves with the experiences and challenges of conducting elections in Uganda.

The delegation was led by Commissioner Dr. Mohammed Swazuri, and included Commissioners Ms. Salome Muigai and Rev Anyonga Zablon, and the Deputy Head of Kenya's Mission in Uganda, Mr. S.K.Maina,

The Chairman of the Electoral Commission, Eng. Dr. Badru M.

Kiggundu, hailed their visit as a positive gesture, symbolising a commitment towards enhancing democracy in the East African Community, through regular free and fair elections.

Eng. Dr. Kiggundu, outlined the history of the Electoral Commission, and briefed the delegation on elections and referendum so far concluded under the constitutional mandate.

He cited late enactment of laws as a major challenge to the Commission, and also noted that some laws have been found to be inadequate, and the Commission has requested for amendments.

Face-to-face With Joy Nandaula, Secretary – QCC

Quality Control Committee (QCC) was recently estab lished within the Electoral Commission. The main task of the QCC is to improve efficiency within the EC by proactively looking out for potential loopholes within the organization, and recommending relevant pre-emptive remedial action. But what exactly is the QCC, and how is it going to function? Joy Nandaula, Secretary to the QCC explains in the following interview with *The EC Bulletin*.

EC B. What is the Quality Control Committee (QCC)?

Joy N. The Quality Control Committee was set up by the Commission to identify areas of improvement in the Commission's activities, set standards, suggest solutions, monitor and report performance.

The idea was derived from a broader term Total Quality Management (TQM) which in recent years has been adopted by most class one Organizations in the world as a way of ensuring continuous top performance.

EC B. Why was the QCC established within the EC and when was it established?

Joy N. The output of the Commission was affected by numerous errors during the discharge of Commission duties, which meant that the quality of Commission work was not satisfactory.

In its 22nd Commission meeting held on Tuesday 13th May 2003 in the Commission Board-room, the Commission discussed and agreed to put in place a Quality Control Committee.

EC B. Who are the members of the QCC, and how were they selected?

Joy N. The following are the Quality Control Committee members:

- 1. Mr.Francis Ojede, Head
- Human Resource Department *Chairperson*
- 2. Mr. Joseph Lwanga, Head Finance Department *Member*
- 3. Mr. Herbert Wamboko, Ag. Head Data Processing Department *Member*
- 4. Mr. Charles Nsimbi, Ag. Head Voter Registration Department *Member*
- 5. Mr. Leonard Mulekwah, Election Officer Member
- 6. Ms. Joy Nandaula, Election Officer
 - Secretary

The members of QCC were selected by the Commission based on their individual capacity.

EC B. What qualities does one have to possess in order to qualify as a Member of the QCC?

Joy N. One has to be mature and have skills and experience in management and trouble shooting. The QCC is also constituted so as to vary the background of the members. This gives the QCC broad knowledge to enable it address several issues within the Electoral Commission.

EC B. How long are the current members of the QCC going to serve?

Joy N. For now the Commission is considering how effective the Committee's performance will be

and after a year, will come out with the duration which shall be, incorporated into the Current Terms of Reference.

EC B. What is the relationship between the QCC and the various departments of the EC.

Joy N. The Committee is mandated to cut across and direct specific issues to all user departments and ensure that they operationise the set standards and control measures. The Committee shall then ensure that the set standards are being adhered to.

EC B. Is the QCC going to visit EC district offices to ensure that acceptable standards of quality are adhered to?

Joy N. Yes, the Committee has arrangements to visit EC District offices. First, we have designed a programme for regional workshops in which we intend to educate field staff on the various electoral activities and the Role of the Committee.

Secondly, we have designed a programme that will ensure that field Officers are adhering to acceptable standards set by the Committee. We shall conduct regular field trips to monitor and spot-check.

EC B. What is the QCC going to do about individual officers who are deemed to be producing poor quality work?

Joy N. The QCC is empowered by the Commission to carry out necessary remedial action ranging from helping the individual to identify gaps and work out solutions to that effect. QCC is also mandated to take action e.g. Disciplinary or any other, to minimize bureaucracy.

EC B. What message do you have for the EC staff with regards to the establishment of the QCC?

Joy N. The message is that, Quality Control Committee is not a new phenomenon restricted to the EC. Other organisations have them too. Total Quality Management (TQM) is a new trend in management, which emphasises continuous improvement.

EC B. Now that a QCC has been established within the EC, what should the public look forward to? *Joy N.* To the public I wish to say that, with the creation of the

Committee, the Commission is ready to ensure that all stakeholders in electoral activities are happy. However the Commission needs to have their support and input towards 'Conducting Regular Free and Fair Elections and Referenda'. The Commission welcomes constructive criticism.

EC Strenghtens Technical Management Team

New Dawn at the Electoral Commission

t the onset 18th Novem ber, 2002, the newly ap pointed Commission found its plate full of numerous challenges, for example, a critical backlog of Parliamentary by-elections, image problem, absence of employment policy, numerous interdicted staff, malaise within rank and file, lack of commitment, and a litigous environment, etc.

This Commission pledged before the appointing authority and the country to commit itself to clean house, uplift the image of the Commission, fulfill the constitutional mandate for which it was constituted namely; conducting free and fair elections and referenda.

Accomplishments

The following is a brief mention of some of the accomplishments, which are both internal and external to the Electoral Commission.

Internal Accomplishments

- Image problem has been addressed internally and externally;
- The recruitment policy has been reformed and put into operation, resulting in employing highly qualified and competitively selected new breed of employees;
- A contract-based engagement of new staff has been evolved;
- Sensitisation of staff regarding delivery of services;
- Adoption of zero tolerance as new policy against indiscipline;
- Creation of a Quality Control Committee, to ensure thoroughness in whatever is done, and,
- An attempt to create a coherent leadership which is mutually accountable for all actions.

Heavy EC Presence at Nakasongola Byelection

The 28th August 2003 fraud-proof bye-election for the District Woman Representative to Parliament for Nakasongola District was another in a series of successes, which underscore the renewed commitment by the EC to strictly comply with electoral laws. To plug-up possible loop-holes in the poll, EC staff from the head-quarters were deployed as presiding officers at all the forty-five polling stations.

Brace Tubwita Bagaya, declared winner by Returning Officer Mr. Opar Malakwang polled 2071 votes, while her sole 'rival' Margaret Komuhangi polled 1988 votes.

EC Chairman Eng. Dr. Badru M. Kiggundu witnessed the declaration of results and expressed gratitude to the people of Nakasongola, particularly the electoral college for successfully concluding the byelection peacefully. He also thanked the various security organs for their tireless efforts to ensure a peaceful electoral process.

Eng. Dr. Kiggundu further commended the high degree of resilience and commitment exhibited by both the election officials and voters, and emphasised the need for continued support towards building a credible electoral and democratic culture in Uganda.

The seat fell vacant after Court nullified the 2001 election of Margaret Komuhangi, citing election irregularities. The petition was filed by her then runnerup, and now winner, Grace Tubwita Bagaya

EC Assures Staff on Restructuring

The long-awaited restructur ing of the Electoral Com mission is finally underway. Before the commencement of the exercise, there was anxiety, speculation and fear among sections of the staff that they would lose their jobs.

EC Chairman Eng. Dr. Badru M. Kiggundu, put such fears to rest, by assuring all members of staff that the restructuring would not result into job losses. He explained that the exercise is meant to improve efficiency in the organisation, by placing everyone where they can serve best.

Eng. Dr. Kiggundu made the clarification during a General Staff Meeting held on 29th July 2003 at the Commission's headquarters.

He appreciated all staff for their input, and particularly noted their ability to handle sensitive and ur-

gent work in a professional manner. He emphasised that there was need for the entire workforce, which, necessitated the recent recruitment of an additional seventyfour (74) new officers.

EC Observes Rwanda Presidential Election

n EC delegation compris ing the Chairman Eng. Dr. Badru Kiggundu, Commissioner Jenny B. Okello and technical officers Ms. Jennifer A. Barya and Mr. Ahmed Ochama was in Rwanda to observe the August 25th 2003, Presidential elections, at the invitation of the Rwanda National Electoral Commission.

A report compiled about the poll indicates that the exercise by-andlarge reflected the will of the people of Rwanda. "The Uganda delegation did not at any time witness any incidence of coercion **10** or threats during the period of observation. In view of this delegation, the elections were free and fair and can be said to reflect the will of the people of Rwanda", the reports reads in part.

The report also highlights some noteworthy features about the way the Rwanda poll was conducted for instance: Stamping of the voter's card after casting the ballot; use of the thumb-print as the only mark of choice by voters; the use of a national identity card to reinforce the text voter's register and polling officers working on voluntary basis.

The EC visited Kacyiru, Kanombe, Kabuga, Muhazi and Murambi districts.

EC Deputy Chairperson, Sr. Margaret Magoba noted that the Institution decided to contract an independent recruit ment firm, in order to hire competent staff. She stressed that the Commission needs the entire present work force, and that no employee would be dismissed unfairly.

Commissioner Joseph N. Biribonwa said such interactive staff meetings would be held periodically, to enable the Commission identify and address the needs and anxieties of the staff.

Other Commissioners present at the briefing included Tom Buruku, Stephen Ongaria and Jenny Okello, who clarified on the restructuring, and other issues of concern to the staff.

New Commission Meets Field Staff

penness with staff and collective decision-mak ing is one of the key hallmarks of the new Commission. At the Institution work is being done through an increasingly participatory approach. Through this strategy, the Commission interacts with field staff, and finds solutions to emerging challenges with them.

In line with this policy, after inauguration, the new Commission conducted a seminar for District Registrars in March 2003 at Hotel Equatoria, Kampala, to interact with, discuss and get abreast with the various aspects pertaining to the Commission's field operations. The workshop, which brought together Commissioners, District Registrars and senior staff from Headquarters, involved several presentations by technical staff, which were moderated by Commissioner and Directors.

Issues addressed included developing a competent cadreship of election officials country-wide, continuous voter education, accountability and the need for different stakeholders to work together to put in place an accurate and credible voters' register.

A representative of the registrars, Ms Joyce Ajupo Wadri (from Kamuli), expressed gratitude to the Commission for the workshop, which she said had presented them with an opportunity to mix with, and share ideas with the new Commission.

Closing the workshop, Commissioner Tom Buruku appealed to the District Registrars to be thorough when executing electoral work. He also advised them to internalise electoral laws to empower them to handle legal challenges that go with managing elections.
