- For effective and successful execution of its mandate, the EC recognizes the role of the various stakeholders.

- You may recall that, on 2nd August 2023, at Hotel Africana, the Electoral Commission (EC) launched its Strategic Plan (2025/26) and the General Elections Roadmap.
- The new revised Roadmap is being unveiled to stakeholders today in preparation for implementing the 2025/2026 General Elections Roadmap.

OBJECTIVES OF THE DISSEMINATION OF THE EC REVISED ROADMAP



- Provide a basis for better planning, implementation, benchmarking and performance assessment;
- Improve stakeholder participation in the electoral process;
- Improve the electoral planning and administration;
- Avoid last-minute rush in implementation of electoral activities;
- Deliver timely electoral results freely and transparently;
- Contribute towards good governance and security.

- According to Article 61(2), The Constitution of the Republic of Uganda, the EC is mandated to hold Presidential, General Parliamentary and Local Government Councils Elections within the first 30 days of the last 122 days of the expiry of the term of Office of the President.
- The current term of office for all elected leaders expires on 12th May 2026.



- 1. Presidential
- 2. Members of Parliament (Constituency Members of Parliament; District/City Women Representatives; and Representatives of Older Persons, PwDs, Youths, Workers and UPDF);
- **3. District/ City Local Government Council** (District Chairpersons/ Lord Mayor; their Councillors including Representatives of PwDs, OPs, Youths, Workers, and Professional Bodies to KCCA);
- **4. Municipality/City Division Local Government Council** (Mayor; their Councillors, including PwDs, Ops and Youths Representatives);



- 5. Sub-county/Town Council/Municipal Division Local Government Council (Chairpersons and Mayors; their Councillors, including PwDs, Ops & Youths Representatives);
- 6. Members of Council/ Committees of Special Interest Groups (PwDs, Youths, Older Persons) from Village to National level;
- 7. Members of Women Council/ Committees from Village to National level;
- 8. Administrative Unit (LC I & II) from Village to Parish level.

Subject to Article 61 as amended, the Roadmap covers the whole electoral process activities of:

- Demarcation of Constituencies
- Demarcation of Electoral areas
- Reorganisation of Polling Stations
- General Update of the NVR
- Display of NVR
- Nomination of Candidates
- Campaigns
- Polls
- Declaration and Publication of Results





The polling for Presidential, General Parliamentary and Local Government Councils for 2026 General Elections shall be between **Monday 12th January 2026 up to 09th February 2026;** hence setting a benchmark for all other electoral activities.

PRODUCTION AND DELIVERY OF BALLOT PAPERS AND DECLARATION OF RESULTS FORMS





Considering the projected 1,908,636 Elective Positions resulting into so many variations for the production of Ballot Papers and Declaration of Results Forms, and with Polling expected to commence by 12th January 2026 it requires adequate time between nominations and Polling to Production and Packing of Ballot Papers and DR Forms.

PRODUCTION AND DELIVERY OF BALLOT PAPERS AND DECLARATION OF RESULTS FORMS



- The Commission has to computerize Candidates Information from the various hard copies of Nomination Forms for each Elective Office, prepare Sample Ballot Papers and carry out quality assurance to ensure each category of election with all its elective offices as Nominated has a correct Sample Ballot Paper.
- The computerization and quality assurance take about **40 days** especially for Local Governments and Parliament respectively.
- Given the many categories of elections and their corresponding elective offices, it requires at least 30 days, to print and deliver ballot papers and declaration of results forms to EC Warehouse.



PACKING OF BALLOT PAPERS AND DECLARATION OF RESULTS FORMS



- Ballot papers and declaration of results are the last items of the Polling Kit to be packed. The Commission requires **at least 30 days** to pack these two very sensitive and important items meticulously.
 - The packing of the ballot papers and declaration of results should end and Polling Kits delivered to District/City Stores **at least 5 days** before Polling Day to allow for verification and arrangement in District Stores in time for Polls, that is, **dispatch starts by Sat 03/01/26 and ends by** Wed 07/01/26.





□ For dispatch to occur starting by 7th January 2026 then:

- Packing should end by 3rd January 2026;
- Production and Delivery of Ballot Papers and DR Forms to EC
 Warehouse should take place between 3rd November 2025 and 3rd
 December 2025;
- Hand over of Samples to Printers is done by 29th October, 2025;
- Computerisation of Candidates Details has to be done between 17th September 2025 and 13th October 2025;
- Hence, the dates for Nominations as Approved.

- Given the magnitude of variations for Production of Ballot Papers, nominations for Local Government Councils should complete by Third week of Sept 2025.
 - Nominations of Parliamentary Candidates shall have completed 17th
 September 2025.
 - For campaigns to commence latest by Second week of Oct 2025;
 Nomination of Presidential Candidates must have completed by then.
 Presidential Nominations must end by 03rd October, 2025 and General
 Parliamentary by 17th September, 2025.



NOMINATIONS





- The Commission has to fulfill Section 8 of Presidential Elections Act and Section 9 of the Parliamentary Elections Act (PaEA) that provide for appointment of nominations days and time.
- The Commission also has to comply to Section 4(4)(a) of Parliamentary Elections Act (PaEA) to enable public servants who wish to participate to prepare accordingly.
 - Deadline for resignation by Public Servants,
 - ✤ Local Governments Sat 02/08/25,
 - Presidential Wed 01/10/25
 - Parliamentary Fri 13/06/25







- An up-to-date and clean National Voters' Register (NVR) is a cornerstone for free-fair-elections.
- EC, Political Parties/Organizations and all stakeholders need an up-todate NVR for the nomination exercises.
- An up-to-date NVR should therefore be ready by **end of May 2025**





- The Commission has to comply with Section 33(3) of the Electoral Commission Act (ECA) to gazette and publicize polling stations at least
 60 days before the Display of the NVR.
 - Preparatory activities for the Display of the NVR should have been
 completed by the Second week of April 2025, i.e. appointment of
 Tribunal Members by the Judiciary, recruitment and training of Display
 Officials





- Display of the NVR shall therefore take place between 18th April and 8th May 2025 in line with Section 25(1) of ECA;
- Display of the Parish Tribunal recommendations will be completed by
 9th May 2025 in line Section 25(1a) of ECA;
- Therefore, processing of Display Returns and production of an up-todate NVR should be completed by the **End of May 2025**.





For an up-to-date NVR to be ready by **end of May 2025**, the General Update of the NVRs (Registration, Transfers) should be done in **January 2025** in line with Sections 19(7) and 19(8)(a) of ECA.



- **Election Key Dates**
- The National Voters Register (Presidential, General Parliamentary and Local Government Councils Elections);
- Voters Register for elections of Special Interest Groups Representatives to Parliament (Youth, PwDs, Older Persons, Workers and UPDF);
- Voter Registers for Elections of Special Interest Groups to Local Government Councils (Youth, PwDs, Workers, Older Persons and Professional Bodies to the Kampala Capital City Authority);



- Voter Registers for elections of members of Councils/Committees of Special interest groups (Youth, PwDs, Workers and Older Persons) from village to national level;
 - Voter Registers for elections of members of Women

Councils/Committees from village to national level;

• Voter Registers for elections at Administrative Units (LC I & II) from Village/Cell to Parish/Ward level.





Article 181 of the Constitution mandates the Commission to demarcate
Electoral Areas (EA) for Local Government Councils Elections to form Local
Government Councils and Sections 108,109, 110 of the Local Government Act
(LGA) guide by spelling out:

Administrative units under play

- Number of inhabitants
- Population quota for women
- Minimum size of any Local Government Council
- Levels of Local Government Councils
- Levels of representation for each Local Government Council
- Important issues like means of communication, geographical futures, density of population, area and boundaries of administrative units like Parishes/Wards







Demarcation of EA is further guided by **Section 10 of LGA** which defines the composition of the local government councils to include seats for special interest groups of youth, persons with disability, women and older persons. Demarcation of EA is planned for **August 2024**.



Section 33 of ECA as amended orders the EC to publicise a list of all places at which the NVR is required to be displayed and a list of all polling stations, at least 60 days before the date of display or polling day.

- Election Key Dates
- Re-organization involves shifting, renaming, creating and/or merging some polling stations.
- The purpose is to;
 - Reduce distance
 - Avoid/reduce overcrowding
 - Catering for newly created Parishes
 - Relocating to more appropriate venues
