**Nomination of Candidates in Electoral Areas where a Nominated Candidate Died**

In accordance with Section 26 of the Parliamentary Elections Act, the Electoral Commission has appointed **Tuesday 22<sup>nd</sup> and Wednesday 23<sup>rd</sup> December 2020** as dates for conducting fresh nomination in the following electoral areas where death occurred of a nominated candidate:

2.	Kyotera District	District Woman Representative to Parliament	Death of a nominated candidate
3.	Bushenyi-Ishaka Municipality	Municipality Chairperson	Death of a nominated candidate
4.	Buliisa District	District Female Councillor Representing Older Persons	Death of a nominated candidate
5.	Lira East Division,	Municipality Male Councillor Representing Older Persons	Death of a nominated candidate
6.	Minziro Parish, Kyebe SCty, Kakuuto, Kyotera District	Sub County Directly Elected Councillor	Death of a nominated candidate
7.	Kisekka Parish, Kisekka Sub County, Bukoto South Lwengo	Sub County Male Councillor Representing Older Persons	Death of a nominated candidate
8.	Rwamabondo Town Council, Kajara County, Ntungamo	Sub County Male Councillor Representing Older Persons	Death of a nominated candidate
9.	Central Ward A, Lukaya Town Council, Kalungu District	Sub County Woman Councillor	Death of a nominated candidate

Please note that the candidates who were previously duly nominated to contest in the above elective positions shall not be required to be nominated again.

All persons participating in the nomination exercise shall be required to comply with guidelines issued by the Electoral Commission in accordance with the Government of Uganda and Ministry of Health measures against the spread of COVID-19.

This includes observing social distancing, hand washing, and wearing of masks.
